Special Flood Hazard Area Zone: This project is for the repair of beach front park facilities that are located in flood zone VE (Coastal High Hazard Zone). Confirmation of location in a Special Flood Hazard Area (SFHA) was made by reference to the latest Flood Insurance Rate Maps, Panel # 4505C0727K. The proposed work conforms to all applicable State of South Carolina and local floodplain regulations. The proposed work has the potential to be affected by its location in a SFHA.

Proposed Work and Purpose:

The City of Myrtle Beach is requesting funds for repairs to a beach front park. The repairs were for replacing a damaged water fountain motor and replacing the panel box at the park. The repairs will return the site to pre-disaster design, function, and capacity.

Project Alternatives:

Alternatives to the proposed action were considered, as follows:

Alternative #1: If no action is taken to repair the water fountain or the panel box, those visiting the park would not have access to clean drinking water.

Alternative #2: Relocating the park outside the mapped coastal high hazard zone is not practicable as the park is functionally dependent on its location in the floodplain. This park is intended to be oceanfront.
